# 6. Accidental Release Measures

**Containment** If greater than >10000L is stored, secondary containment and emergency plans to

#### **Engineering Controls**

PVC or rubber boots must comply with AS/NZS 2210.2 and selected and maintained in accordance with AS/NS2210.1. Remove protective clothing and wash exposed areas with soap and water prior to eating, drinking or smoking.

# Respiratory

If using a respirator, ensure that the cartridges are correct for the potential air contamination and are in good working order. Fit testing and clear guidelines and training for use and maintenance of PPE are necessary.
