4. First Aid

Exposure

Swallowed

IF SWALLOWED: Call a POISON CENTRE or doctor/physician if you feel unwell. Rinse mouth. Do NOT induce vomiting. Give a glass of water to drink.

Eye contact

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE or doctor/physician.

Skin contact

IF ON SKIN: Wash with plenty of soap and water. If skin irritation occurs: Get medical advice/ attention. Take off contaminated clothing and wash before re-use.

Inhaled

Generally, inhalation of fumes/vapours/dusts is unlikely to result in adverse health effects. If coughing, dizziness or shortness of breath is experienced, remove the patient to fresh air immediately. 5. Firefighting Measures

Fire and explosion hazards:

There are no specific risks for fire/explosion for this chemical. It is non-flammable.

Suitable extinguishing substances:

6. Accidental Release Measures

Containment

If greater than >10000L is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.

Emergency procedures

In the event of a large spillage (>100L) alert the fire brigade to location and give brief description of hazard.

Stop the source of the leak, if safe to do so. Wear protective equipment to prevent skin, eye and respiratory exposure. Clear area of any unprotected personnel. Contain using sand, earth or vermiculite. Do not use sawdust. Prevent by whatever means possible any spillage from entering drains, sewers, or water courses. (If this occurs contact your regional council immediately).

Clean-up method	Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.
Disposal	Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Dispose of only in accord with all regulations.
Precautions	Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation.

7. Storage & Handling

Storage	Avoid storage of harmful substances with food. Store out of reach of children. Containers should be kept closed in order to minimise contamination. Keep from extreme heat and open flames. Avoid contact with incompatible substances as listed in Section 10.
Handling	Keep exposure to a minimum, and minimise the quantities kept in work areas. See section 8 with regard to personal protective equipment requirements. Avoid skin and eye contact and inhalation of vapour, mist or aerosols.

Engineering Controls

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Exposure can be reduced by process modification, use of local exhaust ventilation, capturing substances at the source, or other methods. If you believe air borne concentrations of mists, dusts or vapours are high, you are advised to modify processes or increase ventilation.

Skin	Avoid any skin contact. Wear overalls, rubber boots and impervious gloves. Nitrile gloves are recommended. Protective gloves or suitably resistant material must comply with AS 2161. Replace frequently. Gloves should be checked for tears or holes before use. Protective clothing must comply with AS 2919, AS3765.1 or AS3765.2. PVC or rubber boots must comply with AS/NZS 2210.2 and selected and maintained in accordance with AS/NS2210.1. Remove protective clothing and wash exposed areas with soap and water prior to eating, drinking or smoking.
Respiratory	A respirator when airborne concentrations approach the WES (section 8). Respirators must have filters appropriate to the duty and comply with AS/NZS1716 and selected, used and maintained in accordance with AS/NS 1715. Use a respirator with a dust/mist filter. If using a respirator, ensure that the cartridges are correct for the potential air contamination and are in good working order. Fit testing and clear guidelines and training for use and maintenance of PPE are necessary.
